CHECKING IN

The office will open about 6:00 am on Monday morning. If you are just starting in the second session and have not yet checked in, you **MUST ARRIVE** at room N322 at the convention center as soon as possible. You must check in before you officiate your first match.

If you do not see the schedule before you go to bed tonight, assume that you will start at 7:30 am and make arrangements to get on the early bus. Breakfast starts at 5:30, the first bus runs at 6:00 am.

CHECKOUT PROCEDURES

ALL referees must check out of the **first session** by verifying their match counts. If you did not complete the online express checkout form (or the schedule/change request form), you have until 5:00 pm on Monday June 17 to dispute your match counts. After that time, all match counts will be considered final and will not be changed. Payments will be made to those who have a completed Reftown account on (maybe) Tuesday.
